**AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS  
AND RESTRICTIONS OF MARCUS POINTE SUBDIVISION AND  
CONSENT TO DEDICATION OR TRANSFER OF CERTAIN  
COMMON AREAS OF MARCUS POINTE SUBDIVISION**

Marcus Pointe Homeowners Association, Inc., a Florida not-for-profit corporation, by and through its President, Eugene Douglas Gooch, hereby certifies that the owners of lots within Marcus Pointe Subdivision (including all additions thereto which have been annexed as well as encumbered and restricted by the Declaration of Covenants, Conditions, and Restrictions of Marcus Pointe Subdivision ("Declaration")), have by written instrument signed by two-thirds of the owners as provided in Article III, Section 3 and Article IV, Section 1. B. of the Declaration (attached hereto as Exhibit "A") and appropriately noticed as provided therein, adopted the following:

1. Amendment to Article I and Exemption. Upon conveyance of each of the following described parcels to Escambia County, Article I, Section 1 of the Declaration (including all supplements and modifications thereto) shall be amended by deleting the following described parcels from the definition of "Common Areas":

Parcels C, D, F and G, Marcus Pointe Subdivision, as recorded in Plat Book 14, at Pages 48 and 48A;

Parcel A, First Addition to Marcus Pointe Subdivision, as recorded in Plat Book 14, at Page 57;

Parcel A, Third Addition to Marcus Pointe Subdivision, as recorded in Plat Book 15, at Page 39; and

That portion of Parcel D, Fourth Addition to Marcus Pointe Subdivision, recorded in Plat Book 15, Page 73, more particularly described as follows:

Commence at the Southwest corner of Lot 37, Block X, Fourth Addition to Marcus Pointe Subdivision, Section 39, Township 1 South, Range 30 West, Escambia County, Florida, as recorded in Plat Book 15, Page 73 of the public records of said County; thence North 68° 16' 14" East for 208.60 feet to a point of beginning; thence North 75° 19' 28" East for 207.99 feet; thence South 18° 20' 25" East for 81.76 feet; thence South 70° 15' 36" West for 206.89 feet; thence North 18° 45' 31" West for 110.11 feet to the Point of Beginning. Containing 0.43 acres more or less.

all in the public records of Escambia County, Florida.

It is the intention of this Amendment that these parcels (upon conveyance to Escambia County, if ever) shall be exempted from any and all restrictions contained with the Declaration and any and all supplements thereto.

2. Consent to Dedication or Transfer of Certain Common Areas Pursuant to Article IV. In accordance with the provisions of Article IV, Section 1. B. of the Declaration, the members entitled to cast two-thirds of the votes of the Association consent to the dedication or transfer of part

of the Common Areas as described above in paragraph 1 to Escambia County for the purpose of owning and taking over the maintenance of the property including the ponds located thereon.

to Escambia County for the purpose of owning and taking over the maintenance of the above-described property including the ponds located thereon. We further consent to amendment of Article I and any other provision of the Declaration of Covenants, Conditions, and Restrictions of Marcus Pointe Subdivision (as recoded in Official Records Book 2917, at page 683, et seq.) and any and all supplements thereto to accomplish this purpose. Upon conveyance of each of these parcels to Escambia County, it is our intention that Escambia County shall be exempt from any and all restrictions contained with the Declaration or any and all supplements thereto burdening the above-referenced property.
